Explanation of Responses:

- The stock options shall vest ratably over three years and become exercisable as to 100% of the shares of Class A common stock on the third anniversary of the grant date, February 20, 2020. The option expires on February 20, 2027.
- Each restricted stock unit represents a contingent right to receive one share of Class A common stock. The restricted stock units will be settled in Class A common stock, cash equal to the fair market value of the specified number of shares of Class A common stock covered by the restricted stock units, or any combination thereof determined by the administrator at the date of grant or thereafter. The restricted stock units vest ratably over three years.
